

#### NOTICES

#### Approved Seed Cane is an inexpensive insurance

Ordering a small amount of approved seed cane every year provides growers with the best possible means of remaining disease-free, ensuring high productivity and higher profitability. Approved seed cane is a valuable insurance against pests and disease on your farm, safeguarding against loss of productivity and profits. It is tax deductible. It replaces cane from your own farm which you would otherwise have used for planting. Your own cane is then free to be harvested and receive mill price. This means the purchase of approved seed cane is a relatively inexpensive exercise for growers.

#### **Annual Crop Data Survey**

All Burdekin growers have now been visited for our annual crop data survey. Data collected is first placed in our hard copy 'ledgers' and then plotted on our GIS map layers in AgDat software. Plant sources for all Burdekin cane are tracked, allowing growers and BPS to see the time since cane used for planting was last hot water treated. BPS staff encourage growers to place orders for treated approved seed cane. Overall pictures of pest and disease control methods emerge on GIS map layers, allowing BPS staff better control and review of district-wide management. Reports are generated to inform internal BPS and BSES control strategies. We appreciate all growers' assistance and time towards maintaining our Burdekin district as among the industry's cleanest regions. Thank

#### Membership details

It is important to keep in touch with BPS to update contact details when there have been changes. #### Fee for service

BPS has discontinued EM mapping and soil testing services and is currently concentrating on our older core activities of distributing approved seed cane and on-ground pest and disease extension with growers. We thank Peter McDonnell for his input during his time as Operations Manager with us. We wish you well with your new ventures Peter!

#### RSD

All BPS mother plots and approved seed cane plots will be inspected for RSD, ahead of plots opening in early April. Samples will be taken from plots and analysed in the Mackay BSES lab. Following this, commercial RSD testing and disease inspection will commence in the Kalamia and Inkerman mill areas. Two mill areas are sampled each year, with Pioneer and Invicta mill areas inspected last year. Growers will be notified before BPS staff enter farms.

### **Plot Opening**

Plots will be opening commencing in early April, weather permitting. BPS does not set prices for approved seed cane. The owners and/or managers of BPS supervised plots set prices. Please contact field staff on the numbers listed below to order and collect your seed cane during the coming year.
